National Legislation Update, Grassroots Advocacy Presentation Go-To-Meeting via internet

The federal community has contributed \$120 billion toward deficit reduction.

Extensive presentation covered history, legislative accomplishments, and what lies ahead.

Numerous threats to federal employees and retirees were prevented. In the 2013 budget agreement, there was no impact on current FEDS and retirees.

NARFE was named as having one of the top 10 lobbying victories in 2013.

We started 114th Congress requesting for \$318 billion in cuts. Threats included changes to FEHBP and decrease TSP G fund rate of return. New hires contribute 6 times more than employees before 2013. 2-year budget deal had no federal employee or retiree impact.

Success should be judged by what happened as well as what did not happen. After 7 years of constant attacks, we have not lost anything. Accomplishments include reduction of the 52% Medicare premium increase, preventing the change to Chained-CPI, Extended Identity theft protection for those impacted by the Data Breach, Postal Reform Bill has not moved forward. FY2017 has seen Congress occupied by the Affordable Care Act (ACA). The big battle will come in FY 2018.

115th Congress. Many members of Congress believe federal benefits are "too generous".

60 votes in Senate required to move bills forward. Our best defense. However, under Budget Reconciliation only requires 50 votes and is not subject to filibuster. Greatest threat Is in FY18 – FY19. Postal reform bill has been reintroduced by Congressman Jason Chaffetz. It has bipartisan support. Forces postal retirees to enroll in Medicare Part B or lose FEHBP

coverage. This sets a precedent. If they can do it to them, they can do it to us. We must work with various committees with oversight. Our benefits were earned fairly. The promise should be broken. 1st priority is to fight Postal Reform. Defend against a broad attack of pay cuts and benefit reductions. This is not the way to attract the best and the brightest to federal service. There are opportunities to gain ground including WEP reform and in making the Medicare Premium Hold Harmless a permanent fix.

Grassroots is an important part of Advocacy.

Congress cares what we think. They need our support for reelection. Convince our legislators that these issues matter to us. Pressure our opponents, support our friends. Build on past success.

The new Legislative Action Center is easy to use and effective. Use it to send action letters and to report congressional contacts. Important to personalize letters rather than just send the form letters.

Other Actions:

Telephone legislators via Capitol Hill Switchboard (866) 220-0044 will connect you to your legislators based on your zip code. When you call, state that you are a constituent and a NARFE member. Co-ordinate with other NARFE members.

CDL's should meet with chapters.

When you visit legislators, leave issue papers. Report your results to NARFE Headquarters.

Training – Congressional Districts/CDLs George Ramirez, CSFC
Legislative Chair

Congressional District Leaders (CDL) are the liaison between the congressional offices and the chapters within a congressional district. By mobilizing and coordinating members of different chapters for various forms of advocacy such as congressional meetings, letter writing, emails, the impact of NARFE in influencing legislators can be increased.

When meeting with legislators, use the highest number of retirees and Active Federal Employees available when giving the number of people you represent. The legislators pay attention to numbers.

The CDL manual is on the CSFC web site. NARFE annually publishes a list of how various legislators voted. Generally, Democrats support NARFE issues 80% of the time while Republicans support NARFE issues 20% of the time. Federal retirements take about 3% of the Budget. 33% of new hires are veterans. 47% of DOD new hires are veterans. 113,000 veterans work for the USPS.

Chapter Centric Advocacy

Get members to act. CDL contacts chapter legislative chair to mobilize members.

Digital Transformation

Congress is active on social media. Tele-Town Hall meetings are safer than some in-person meetings.

Chapter meetings should provide members with what they need. Is your meeting worth going to? Consider a special brainstorming meeting to determine what your members are looking for. You can get some ideas from the Chapter and Federations Officers Manual, F-10. See Appendix A for a checklist of chapter operations. See what you can do to improve meeting attendance and participation and keep chapters active. Consider thanking members for membership and let them know what the chapter provides for the member. Keep members informed with monthly newsletter. Keep engaged with community. The National Division members pay the Federation for service and the Federations should consider how they can provide service to those members. We are all NARFE members. Come together and work together to improve NARFE.

Membership

As of March 31st Region 8 has 22,678 members and 5,525 National members. National members account for 25% of the membership.

In California, there are 18,478 members and 4,413 National members. National members account for 24% of the membership.

The potential membership in California is 420,417 offering many chances to recruit. The recruiting Power Point presented by Jerry Hall will be posted on the federation web site.

The new renewal letters give members the option of renewing for 1 year for \$40, 2 years for \$72 or 3 years for \$102. The letter also says, "You can join NARFE" or "Join NARFE and a chapter for "\$45, \$82 or \$117". On the back of the letter is a dues withholding form. Several members have inadvertently become National only members. Advise chapter members to be careful when filling out the renewal letter/form.

Bob Davidson II Chapter 455 asked if headquarters will tailor each letter to the chapter's local dues. Answer: Yes, the letter will include the local dues of the chapter of record.
